Co-responsibility agreement - COVID-19 emergency additional part

It was necessary to integrate the educational agreement of co-responsibility between school, families and students to face up the reduction of Covid-19 contagion spreading and to assure a safe and serene start of the 2020/21 school year.

Families or holders of parental responsibility will have to respect the "preconditions" for their children's school attendance in the next school year. Indeed, not only is the agreement a pedagogical document about sharing educational aims between school and families, but also a contractual document requiring the signing by each student/parent, aiming at mutual engagements.

This agreement is based on the opinion of the Tecnichal-Scientific Committee (CTS) set up in the Civil Protection Department and it can be subject to changes or integrations according to the future spreading of the epidemiological emergency.

SIGN THE FOLLOWING MUTUAL RESPONSIBILITY AGREEMENT

In particular the school undertakes to:

- arrange meetings with RSPP, competent Doctor, EELL, Covid Committee for support to Health emergency, in order to examine the several actions to be taken to limit the risk of contagion;
- ensure the implementation of the regulatory protocol to counter and limit the Covid-19 virus spreading at school;
- implement the best educational and organizational measures to ensure the curriculum while also providing, if necessary, online lessons – in accordance with school environment and organization conditions;
- train the staff adeguately on sanitary procedures against infection spreading. The staff itself is committed to the scrupolous observance of every health requirement and will not go to work if symptoms of Covid-19 occur;
- carry out further trainings for teachers on digital skills and integrated teaching to implement and consolidate teaching practises in support of online teaching and learning practices (DaD);
- take initiatives to develop digital skills for students and, if possible, for families;
- provide parents with precise information about health and hygiene devices adopted to limit the Covid-19 spreading and to communicate further changes or integrations related to the measures taken;
- promote parents' partecipation in training and information initiatives about covid-19 risk management and encourage the co-responsibility among school staff, teachers, students and families;
- strictly respect the competent Health Authority requirements in the case of confirmed Covid-19 infection;
- strictly respect the competent Health Authority requirements in the case of a student with Covid-19 symptoms at school;
- monitor the proper application of behaviour rules, regulations and prohibitions according to the measures taken by the competent Authorities.

Parents or holders of responsibility undertake to:

- read the Protocol for managing the Covid-19 health emergency, ensuring the application related to the part under their responsibility (especially the rights and duties about individual and collective health) and constantly be informed on initiatives related (checking the school website and the electronic school register);
- share and support school measures positively in order to grant all school activities safely;
- check daily their own children's health and keep them at home with Covid-19 symptoms (in particular with breathing symptoms and temperature above 37,5°C), immediately informing the family doctor or the pediatrician, following his/her recommendations and instructions;
- go immediately to school and get their children in case of sudden symptoms relating to Covid-19, ensuring constant availability of a family member or someone in charge, during the school day;
- agree, in case of positivity, that their own son or daughter will not be admitted to school activities at school until full recovery, certified according to rules;
- encourage their own children's independence and sense of responsibility and foster proper behaviour towards the adopted rules in every area to prevent and counter the virus spread;
- promote the children's partecipation in online learning if necessary;
- encourage proper use of electronic devices supplied to children, both in and outside school and exert the educational function according to the school measures;
- attend meetings with teachers, even online;
- submit, discuss and share with their own children the educational agreement undersigned with the educational Institution;
- stick to the rules related to the families' access to school administrative offices.

They also state:

- they are conscious that with the start of an interactive activity, even though controlled, it will not be possible to eliminate the risk of infection that, on the other hand, will have to be reduced to the minimum thanks to the scrupulous and strict observance of safety and precaution measures taken by the proper school activities protocols. And, for this reason, it will be important to observe extreme caution even outside school context;
- they are aware that in case of temperature (above 37,5°C) or of other symptoms (mentioned above), the school will provide for isolation of the student together with a reference adult and it will immediately call the family;
- they are aware that, in case of positivity, their own son or daughter will not be admitted to activities at school until full recovery certified according to rules.

The student (primary and secondary school) undertakes to:

- comply with the regulatory protocol of measures for fighting and containing the spread of covid-19 virus at school (distance between people, use of protective equipment -masks-hygiene/personal disinfection, respect the times for entry the school, ...);
- promptly inform the school of changes in his/her state of health which may be related to a Covid19 infection (fever, cold, conjunctivitis, cough etc.) to allow the implementation of the planned protocol;
- support the proper carrying out of all school activities, ensuring attention and active participation both in presence and remote classes;
- use in a correct way on loan or personal electronic devices to support teaching, in compliance with the law, avoiding the violation of other's privacy and dignity, cyberbullying and bullying in general;
- convey/share all communications coming from the school with his/her family members/tutors.
