SUBJECT: INDICATIONS ABOUT THE BEGINNING OF THE NEW SCHOOL YEAR 2020/2021

Dear families,

taking into account the progressive indications provided by the Public Authorities and the Health and Scientific Authorities, the school has reorganized the service and defined what will be applied during the school year 2020/2021 for the protection of students, teachers, school staff, parents and of every person who comes into contact with the Institute (on the website - section: Institute - voice: Security - protocols with organisational measures for each school have been published).

In any case, the taken decisions and the made choices to define the conditions for the safe resumption of teaching and educational activities could vary, taken into account the current evolving context and the not fully foreseeable epidemiological framework.

An even closer cooperation between families and schools will have to be established during the school year 2020-2021. The emergency that is not over yet will force changes to the ordinary school life, which will reflect on families' daily life and habits too.

All families are therefore asked to read carefully the institution regulation additional part and the co-responsibility agreement for the current health emergency attached to this document, in addition to the security-covid protocols drawn up for each school and published on the site.

We inform you that there will be online briefings on Meet, with RSPP (Head of Security, Prevention and Protection) and with the School Director, to illustrate the procedures described in the protocol and the integration of the co-responsibility agreement which must be signed. These briefings will be addressed to all representatives, to the children's parents and to the parents of the students of primary and secondary school first classes.

In addition, a class meeting for the parents of the students of the other classes will take place before the beginning of school. During this meeting the teachers will illustrate the aforementioned documents.

The invitation for both meetings will be sent to the institutional mail of your son/daughter (it is therefore essential for the new students to activate/check the institutional accounts as soon as possible).

The dates of the online meetings with the RSPP, the School Director and her collaborators are:

Monday 7th September at 5pm, meeting with the class representatives of all kinds of school (childhood, primary and secondary)

Monday 7th September at 6pm, meeting with the nursery school children's parents

Wednesday 9th September at 5pm, meeting with the parents of the students of primary school first classes

Thursday 10th September at 5pm, meeting with the parents of the students of secondary school first classes

Class meetings with teachers:

Tuesday 8th September at 6 pm, addressed to 4/5-year-old children's parents of each class of the nursery school

Friday 18th September at 6pm, addressed to 3-year-old children's parents of each class of the nursery school

Wednesday 9th September at 6pm, addressed to the parents of the students of the two primary schools I, II, III, IV and V classes

Thursday 10th September at 6pm, addressed to the parents of the students of the two secondary schools II, III classes

We reiterate that the families' commitment will have to be aimed at:

- 1. respecting the rules established by the school and all the institutions;
- 2. ensuring the students' health conditions control before entering school
- 3. educating the children to respect the prevention measures (interpersonal distance, use of the masks, hand hygiene, etc.);
- 4. avoiding gatherings at the entrance and at the exit of school (it is advisable not to come too early and not to stay in front of the school after having brought and picked the child up);
- 5. keeping up to date with information provided by the Institute and the Institutions and consulting the website and the electronic register.

Please refer to the attached file for the timetable and the methods of entry and exit, which will be explained during the meetings (approved by the School Board on 1st September 2020).

One's own state of health and minors' state of health are entrusted to individual and parental responsibility.

Parents are asked to download the co-responsibility Agreement attached to this communication and to sign and return it on the first day of school (on 9th September for nursery school, on 15th September for primary and lower secondary school), together with the antiinfection measures self-declaration and the autonomous school exit permission form (to be downloaded on school website only for secondary students).

In case someone should not be able to print the three forms that have to be returned on the first day of school, they can call the reception and make an appointment to receive the three copies, from 4th to 11th September from 8:00 am until 2:00 pm.

These forms will be handed over outside school by the school janitors in accordance with the current rules (distance, mask, gloves or hand disinfection..).
